CANCELLATION POLICY

There are no refunds 15 days prior to the event.

Table Space

1. Mini con will provide (2) badges for each space. If you need additional badges, there will be a \$10 fee for each.
2. Each table is for 1 vendor and helper. Additional badges must be purchased for any helpers or guest you wish to bring
3. Location of vendor's space is at the discretion of the board. Please give a detailed description of your setup and needs so we can best accommodate you.
4. Vendor table discounts are for bringing your own 6 foot table. Booths may bring any size

Merchandise for Sale

1. Exhibitor agrees not to sell any adult material to minors. This includes the sale of weapons.
2. We are a family friendly show and discourage adult materials. All adult materials must be either behind the table or, if displayed on a table or display rack, bagged or covered so that minors may not open it.
3. Any adult material containing nudity must be covered with accordance of local and state laws.
4. Exhibitor agrees that all merchandise for sale is legal and licensed.
5. State tax is the responsibility of the artist or vendor to collect according to state laws.

Setup

Load in will be in the back of gymnasium as well as dealer parking

Load will start no later than 6am

There will be a soft opening for attendees with disabilities at 10am and official opening at 11am

Break down will start at 5pm

Liability

1. Under no circumstances shall Mini Con be liable for any lost profits or any incidental, special, indirect, punitive or consequential damages whatsoever for any of the acts or omissions whether or not apprised of the possibility of any such lost profits or damages
2. The Exhibitor agrees to protect, keep and save Mini Con, the promoter of the Event, The association of Animation and the Arts, forever harmless from any damage(s) or charge(s) imposed for violations of any ordinance or regulation by the Exhibitor, his employees or agents, as well as failure to comply with the terms and agreements of this contract. Further, Exhibitor shall at all times protect, indemnify, save, and keep harmless Mini Con against and from any loss, cost damage, liability, or expense which arises out of or from or by reason of any act or omission of the Exhibitor, his employees, or agents.

Exhibitor agrees to indemnify and hold harmless Mini Con, the promoter of the Event, The association of Animation and the Arts, for any injuries that occur within Exhibitor's space or injuries that are caused by the actions of Exhibitors or its agents. Exhibitors must comply with all state, local, and federal laws
